Float Applications and must be received by Wednesday, December 3, 2025. Applications can be dropped off at the MainStreet Roswell office at JP White Building, 105 W. 3rd, 4th floor or mailed to: MainStreet Roswell, P.O. Box 1328, Roswell, NM 88202 Email to: director@mainstreetroswell.org or text form to 575-914-8017. Payment can be made via cash or check.

- Floats will LINE UP from 3:00pm 5:30pm according to your assigned #, on Grand Avenue in front of the Wool Bowl, travel South to College Avenue and South on Main Street. Disbursing East at 3rd Street and Virginia. Floats that arrive after 5:30pm or without an assigned # will NOT be judged.
- 2. Parade starts at 6:00pm SHARP!

Other

- 3. NO STOPPING ALONG PARADE ROUTE KEEP MOVING unless directed by coordinator.
- Absolutely NO candy or other items will be thrown or dropped from the float or vehicle.
   Walking ONLY Candy can be handed out.
- 5. Getting on and off vehicles or floats is STRICTLY prohibited.
- 6. No loud noises, including but not limited to revving engines, burnouts, backfiring, rolling coal and offensively loud or inappropriate music.
- 7. Fire extinguisher MUST be on the vehicle or float.
- 8. All parade entrants MUST obey law enforcement directions Roswell Police Department or Chaves County Sheriff's Department
- 9. Neither MainStreet Roswell, the Holiday Light Parade nor the City of Roswell will be held responsible for any accident or injury resulting from the parade.
